Guidelines for Tuition Fee Waiver Scheme

Tuition Fee Waiver (TFW) Scheme (For Punjab resident candidates only)

- Sons/Daughters of parents whose annual income from all sources does not exceed **₹8.00 Lakh**.
- The Waiver is limited to the Tuition Fee. All other Fees except Tuition Fee shall have to be paid by the beneficiary.
- In the event of non-availability of students in this category, the same shall not be given to any other category of candidates.
- A student admitted under this scheme shall not be allowed to change the Institution/ Course under any circumstances.
- Allocation of TFW seat is subject to the approved Intake sanctioned by affiliating university.

Documents required : Tuition Fee Waiver (TFW) Scheme

- a) **Income Tax Returns** for the Assessment Year 2026-27 - of earning Parents/Guardians.
- b) **Affidavit** stating Parents/Guardian Total income (from all sources) duly attested by Executive Magistrate. – for Assessment year 2026-27. **(Two copies in original as per prescribed format but attach photocopies with application/admission form)**
- c) Parents/Guardian **Total Income (from all sources) Certificate** issued by Revenue Officer not below the rank of Tehsildar. Employed Parents/Guardians are required to obtain Income Certificate from their employer and also obtain consolidated certificate from Revenue Officer for any additional source of income for Assessment year 2026-27. **(Attach photocopy with application/admission form)**
